

## Parent Directive

As the parent, or legal guardian, of \_\_\_\_\_ (child's name), I have the fundamental and legal right to direct the upbringing and education of my child. Therefore, for my child's attendance at \_\_\_\_\_ School for the school year 20\_\_ / 20\_\_, I formally request my child:

\_\_\_ not be administered any formative or summative assessment related to the Common Core State (Kansas College and Career Ready) Standards or used to assess student learning, including all state assessments (integrated or stand-alone), the NAEP, PISA, etc. without my explicit fully informed consent.

\_\_\_ be prohibited from using any school issued computer or handheld mobile device or be required to use any personal computer or device for education purposes without my explicit fully informed consent.

\_\_\_ in the event of a remote learning situation not be subjected to any observations or visual or audio recording of the interior of my child's home or other people. In no way and at no time shall the authority of the school district, its employees or agents, extended beyond the school building of attendance. Participation in any remote learning construct or use of any school electronic device does not constitute my consent for any search (via video, audio or otherwise) of our property.

\_\_\_ not be included in any individual data accessibility, sharing, or reporting to any State or Federal agency, contractor or vendor of any individual data about my child or any associated family member without my explicit fully informed consent.

\_\_\_ not participate or be included in any human sexuality, Social Emotional Learning (SEL) - including any Critical Race Theory (CRT) curriculum - programming, recording of any data, or measuring, without my explicit fully informed consent.

\_\_\_ not participate in any surveys (personally completed or completed via staff observation), questionnaires, or any other tool used to reveal and record any attitudes, beliefs, behaviors, etc. without my explicit fully informed consent.

\_\_\_ not receive any materials or participate in any instruction, activities, or events or have any interaction with school employees or agents acting in the capacity of nurses, counselors, psychologists, social workers, community initiatives, diversity or equity programming without my explicit fully informed consent.

\_\_\_ not be mandated or coerced to receive or engage in any medical surveillance or therapy (masks, temperature checking, inoculations, medicines, etc.) without my fully informed consent.

\_\_\_ not participate in any school administrative matters, academic or extra-curricular curriculum or programming that requires the violation of my child's personal privacy, including scanning of personal electronic devices on school property, fingerprint scans, drug testing, face scans, etc. without my explicit fully informed consent.

\_\_\_ not be included in the school's agreements with third parties (contractors, vendors, or government agencies) that allow the school to proxy for me, the parent, without my explicit fully informed consent.

My child will not face any negative consequences to course grades, academic evaluations, workload, promotion, future classroom assignments, or treatment by school staff and agents.

If there are any questions on the part of any school employee or agent as to the application of this directive in regard to any specific academic, non-academic, or extra-curricular programming, the school shall act in an abundance of caution and not proceed with my child's inclusion or participation. I am happy to be contacted by the school to clarify specific items.

All school data (both digital and non-digital) on my child is to be readily available and producible to me, the parent.

Those school district employees, school district partners, elected officials, school district contractors or vendors who violate this notice pursuant to my fundamental parental right to exercise primary control over the care and upbringing of my child shall be held accountable to the fullest extent of the law.
